SCHOLARSHIP APPLICATION

The North Carolina Association of Floodplain Managers (NCAFPM) is co-hosting the **2023 ASFPM Annual National Conference, May 7-11, 2023**, at the Raleigh Convention Center in Raleigh, North Carolina. As the Host State, **Floodplain Managers (Village/Town/City/County Government Officials) throughout North Carolina are eligible to apply for a SCHOLARSHIP to attend the 2023 ASFPM National Conference. This scholarship will provide the registration fee for early conference registration. 34 (total) scholarships are available for award. These scholarships are funded by the Federal Emergency Management Agency (FEMA).**

Workshops/field tours, overnight accommodations, travel, and any other conference expenses will not be covered by the scholarship and will be the responsibility of the recipient or their agency. Scholarships will be limited to one applicant per jurisdiction and will be awarded on a first-come-first-serve basis. Priority will be given to applicants from communities with high social vulnerability. Applications in excess of the available scholarships will be added to a waitlist and notified if a scholarship becomes available.

Applications should be submitted no later than April 21st, 2023. Notification of scholarship award will be provided by **April 28, 2023. Do not complete ASFPM's online Conference Registration, you will be required to submit a paper Registration.** Those NOT receiving a scholarship will still have time to register at the early discount rate. In order to receive this scholarship, applicants are required to volunteer at the conference for at least four (4) hours. Online volunteer registration is open. Scholarship Criteria

- Attendees must be a Village/Town/City/County Government Official performing Floodplain Management duties within North Carolina.
- Attendees must be able to attend the full conference (Tuesday-Thursday).
- Attendees must volunteer at the conference for at least 2 hours. (Volunteer positions range from room monitoring, checking badges, etc. No heavy labor will be required.)
- Attendees must complete and return the Scholarship Application by the specified deadline.

Membership in NCAFPM or ASFPM is not necessary to apply for and/or receive a Scholarship for the ASFPM Conference and will not be a factor in choosing successful applicants.
